Booking conditions (English)

These Booking Terms and Conditions apply to natural persons borrowing equipment from Kapital Ry.

When borrowing equipment, the following conditions are applied:

1. **Members of the guild**, who have paid the membership fee can borrow the guild's equipment by agreeing with a member of the board. Equipment loans must be electronically marked (e.g. text message)
2. **Price**. The association can charge a fee according to its price list for borrowing products.
3. **Duty of care**. The borrower undertakes to handle and store the loaned equipment carefully.
4. **Equipment use**. The equipment is borrowed for the borrower's own use. Renting and passing on the equipment to a third party is prohibited.
5. **Cancellation of reservation**. The reservation must be canceled 2 hours before the time set to start the reservation.
6. **Returning equipment**. Borrowed equipment must be returned to the association's official within the agreed time
 - a. The association's employee has the right to check the equipment before returning it to find out any possible damage.
7. **Loan period and penalty for overstaying**. Borrowed equipment must be returned in such a way that it is in the possession of the association at the latest at the end of the loan period. The association can charge the borrower a late fee of 50 euros for each equipment returned late for each day of delay.
8. **Smoking**. Smoking is strictly prohibited in the immediate vicinity of the equipment. The association has the right to charge a cleaning fee of 25 euros for tobacco products found in the equipment.
9. **Responsibility to inform**. From possible visible marks on the equipment. The booker is obliged to inform the official of the association about any visible marks (for example, paint) on the equipment.
 - a. For unreported damage or inconvenience, the association has the right to charge 10 euros in addition to possible repair costs.

10. **Liability for repair costs.** The borrower is responsible to the association for all repair costs caused by damage to the rented equipment during the loan period, regardless of who caused the damage.
 - a. the chairman of the guild can alone refuse the obligation to compensate
11. **Liability for loss.** The borrower is responsible for the loss of the equipment. If the borrowed equipment is lost or it is lost through a crime, the borrower must pay the association the replacement value of the equipment.
 - a. the chairman of the guild can alone refuse the obligation to compensate
12. **Penalty for not returning.** If the borrower does not return the borrowed equipment within four weeks of the end of the loan period, despite the prompt given to him, the board of the association can decide that the equipment is interpreted as lost and that the borrower must pay the association the replacement value of the equipment.
13. **The right to cancel or transfer the reservation.** In case of force majeure or if the booker has not followed the booking conditions, the association has the right to cancel the booking. The association also has the right to transfer the reservation if the equipment reserved by the customer leaves the association's agency or is not available for other reasons. currently in use. When doing so, the booker is contacted.
14. **Limitation of liability.** The association is not responsible for any indirect or direct damages caused by the use of loanable equipment or for damages based on liability for damages or special damages.

ACCEPTANCE OF AGREEMENT

You accept the above-mentioned conditions and are obliged to comply with them in the manner required in the conditions before the start of the reservation, during the reservation and during any inspection by the association's official.
